Mayor Franklin advised that he has withdrawn his support from this project. Google no longer agrees to use the existing infrastructure and instead wants to trench City streets to lay cables. He is concerned that this will damage our streets and that Google will not be responsible for any future repairs that might be needed. Additionally, future internet use may not even require physical cable systems. He expects that Google or another provider will step in and install high speed service as originally specified.
