- **A.** The monthly meeting of City Commissioners was called to order by Mayor Bruce Barbour at 7:00 PM in the Broadway Baptist Family Life Center, 4000 Brownsboro Road.

1. Monthly financial reports:

The City has a total of \$ 293,245.80 in available funds--\$ 179,686.69 in the General Fund, \$ 12,307.54 in the Road Fund and
\$101,251.57 in the Investment Account. See expenditure/revenue details in the attached report.

2. Key transactions in August.

Mr. Strebel reported that the City paid Greenhaven Tree Care to prune the viburnums around the AT&T boxes and to inspect several trees in the City. Total was \$540.00.

3. Status report on 2019 property tax receipts.

Mr. Strebel reported that 160 of 178 tax bills have been paid to-date. Total collected is \$41,874.74. Eighteen bills remain outstanding--- total due is \$4,333.76 (with penalties).
